- The Lease is strictly for Residential purpose to accommodate the occupier of the LESSEE. The Lease is according to the English Calendar/Monday.
- The LESSEE has agreed to pay the Monthly Amenity charges on or before 5th day of the every succeeding month for the demised property more fully described in the SCHEDULE hereunder in the following manner:
 - Rs XXXXXX.00 per month (Rupees Three Thousand Five hundred only) towards Rent.
